## Latest Requirements from Oregon Department of Education

- Face Masks
- Social Distance







#### **EPSD9 Schooling Options**

#### **On-Site Learning**

**Traditional Model** 

Students attend neighborhood school "in-person," five days a week.

\*If allowed by Governor's Metrics

#### **Hybrid**

**Non-Traditional Model** 

Half of the students attend "in-person" classes at school while the other half learns virtually from home. AKA: "Brick" and "Click"

Students would rotate days

\*If allowed by Governor's Metrics

#### **EPSD9 Schooling Options**

### Comprehensive Distance Learning (CDL)

#### **Temporary**

Students taught virtually by their EPSD9 teacher(s) and supported by district adopted curriculum.

Students will eventually return to in-person learning at their regular school.

\*If On-Site & Hybrid are not available options.

#### **URCEO VIRTUAL**

**One Year Commitment** 

Students taught virtually by EPSD9 teacher(s) and supported by district adopted curriculum.

A virtual school in which students complete all coursework at home.

Instruction will include synchronous (scheduled) and asynchronous (independent) learning.

#### Ready Schools, Safe Learners: Community COVID-19 Metrics

Returning to "In-Person" Instruction through the "On-Site" or "Hybrid" Instructional Models requires meeting Oregon Department of Education's (ODE) metrics. The requirements or metrics consider local as well as statewide conditions. To return to "On Site" or "In Person" instruction, these conditions must be met:

- **□** Schools must be in a county that is no longer in baseline
- ☐ The following County Metrics must also be met for three weeks in a row:
  - **□** Case rate: ≤10 cases per 100,000 population in the preceding 7 days
  - **□** Test positivity: ≤5% in the preceding 7 days

#### AND

- ☐ The following State Metric must be met three weeks in a row:
  - **□** Test positivity: ≤5% in the preceding 7 days

#### Exceptions to the Metrics: K-3, Special Education Programs, ELL, & CTE

Criteria to open for K-3, Special Education Programs, ELL, & CTE in-person:

- □ COVID-19 is not actively spreading among the school community;
- The case rate in the county is <30 cases per 100,000 population in the preceding 7 days for the past three weeks;
- The test positivity in the county is ≤5% in the preceding 7 days for the past three weeks; and
- Schools fully comply with sections 1-3 of the Ready Schools, Safe Learners guidance.
